ADMINISTRATIVE ORDER No.014-2017

ORGANIZING THE EXPANDED UGNAYAN NG MGA BARANGAY AT SIMBAHAN TECHNICAL WORKING GROUP (UBAS-TWG)/MASA MASID MONITORING GROUP IN THE MUNICIPALITY OF LA TRINIDAD.

WHEREAS, Article II, Section 23 of the 1987 Philippine Constitution stated that, "The State shall encourage non-governmental, community-based, or sectoral organization that promotes the welfare of the nation;

WHEREAS, in Section 3 (1) of Republic Act No. 7160, also known as the Local Government Code of 1991, stated that "*The participation of the private sector in local governance, particularly in the delivery of basic services, shall be encouraged to ensure the viability of local autonomy as an alternative strategy for sustainable development*" and in Section 35, stated that, "*Local government units may enter into joint ventures and such other cooperative arrangements with people's and non-governmental organizations to engage in the delivery of certain basic services, capability building...*";

WHEREAS, DILG Memorandum Circular No. 2016-116 entitled "Implementation of MASA MASID (Mamamayang Ayaw sa Anomalya, Mamamayang Ayaw sa Illegal na Droga)" specified that "the MASA MASID program is a community-based initiative to engage volunteers in the fight against criminality, corruption and illegal drugs. This program adopts a multi-sectoral and mass-based approach to ensure an effective war against illegal drugs and illegal drug-related crimes;

WHEREAS, the expanded UBAS Technical Working Group (TWG)/MASA MASID Monitoring Group will serve as the social-facilitator and will be responsible in convening, organizing, training and mobilizing the MASA MASID Team at the barangay level;

NOW THEREFORE, I ROMEO K. SALDA, by virtue of the powers vested in me by law as the duly elected Municipal Mayor of La Trinidad, Benguet, Philippines, do hereby order and direct the following:

SECTION 1. COMPOSITION. The La Trinidad Expanded Ugnayan ng mga Barangay at Simbahan-Technical Working Group (UBAS-TWG)/MASA MASID Monitoring Group is hereby organized to be constituted by the following:

SECTION 2. SECRETARIAT. The following representatives of the La Trinidad Municipal Anti-Drug Abuse Council (MADAC) shall act as the Secretariat:

Chairperson : MR. JOEL CERVANTES, CAO, MADAC Head Secretariat
Members : MS. ROSE NOEMI T. CO, Population Officer
MS. MARIA LOURDES G. TAGUIBA, SWO 1, MSWD

SECTION 3. ROLES AND FUNCTIONS. The Expanded UBAS Technical Working Group shall have the following functions:

- a. Research, document, disseminate information and create guidelines in the implementation of related programs and projects;
- b. Convene and mobilize the MASA MASID Teams;
- c. Provide appropriate technical and administrative assistance to the program.
- d. Implement a systematic monitoring and reporting mechanism.

SECTION 4. MEETINGS. The expanded UBAS-TWG may meet as often as it deems necessary at a particular date, time and place as the Chairperson of the TWG may designate in the notice.

SECTION 5. REPEALING CLAUSE. Administrative Order No. 08-2017 is hereby repealed in its entirety. Further, all issuances, orders and memoranda issued inconsistent herewith are hereby nullified and/or repealed.

SECTION 6. EFFECTIVITY. This Administrative Order shall take effect immediately
