ADMINISTRATIVE ORDER
No. 036-2016

AN ADMINISTRATIVE ORDER CREATING THE EXECUTIVE-LEGISLATIVE TEAM OF THE MUNICIPALITY OF LA TRINIDAD, BENGUET.

WHEREAS, the Local Government Code mandates local government units to prepare a Comprehensive Development Plan (CDP) that outlines the key aspirations, challenges and concerns facing LGUs and a set of programs and policies towards the sustained socio-economic development;

WHEREAS, the Executive-Legislative Agenda (ELA) serves as an implementing mechanism for the CDP, and its process ensures that the plan is reflective and supportive of the sentiments of the local community and has generated popular support from various stakeholders in the LGU;

WHEREAS, the ELA process requires a team that will back up the Local Chief Executive in the various preparatory, consultative and technical activities in order to come up with good quality and acceptable outputs;

NOW THEREFORE, I, ROMEO K. SALDA, Municipal Mayor of the Municipality of La Trinidad, by virtue of the powers vested in me by law, do hereby create and mobilize the Executive-Legislative Agenda Team to wit:

SECTION 2. FUNCTIONS AND DUTIES OF THE EXECUTIVE LEGISLATIVE AGENDA TEAM.


- a. Review available plans and documents and gather data required in the development of ELA;
- b. Assist the LCE in public hearings and other consultation sessions with the various LGU stakeholders and affected sectors like the LGU Offices, MDC, Sanggunian and other sectoral organizations;
- c. Assist the LCE and MDC in drafting and finalizing the ELA to include the 3 years LDIP, current Executive Budget and AIP;
- d. Assist the LCE in his presentation of the ELA to various stakeholders; and
- e. Do other tasks required by the LCE in order to produce the desired outputs.

SECTION 3. RELATIONSHIP WITH THE MDC AND OTHER UNITS. The ELA Team shall work closely with the Municipal Development Council (MDC) as soon as it is reconstituted. The MDC shall act as the reference group for the ELA Team and shall participate actively, through its representative, in all stages of the ELA process.

SECTION 4. SUPPORT REQUIREMENTS. The Team may call upon the assistance of relevant units and/or LGU Personnel, through the respective department/unit head in the implementation of various activities. Everyone is enjoined to participate in the various activities of ELA.

SECTION 5. EFFECTIVITY. The ELA Team shall exercise their functions and duties effective immediately until the project closes.
