## ADMINISTRATIVE ORDER NO. 055-2016

AN ADMINISTRATIVE ORDER REORGANIZING THE MUNICIPAL AWARDS COMMITTEE (MAC) FOR THE ANNUAL LUPONG TAGAPAMAYAPA INCENTIVES AWARDS (LTIA) PROGRAM

WHEREAS, Executive Order No. 394 dated January 22 1997 established the Annual Lupong Tagapamayapa Incentives Award (LTIA) aims to accord official recognition and tribute to Lupons for reasons of exemplary performance in the implementation of the Katarungang Pambarangay at the grassroots;

WHEREAS, DILG Memorandum Circular No. 2008-102 dated June 17, 2008 as enhanced by DILG MC No. 2016-58 dated April 29, 2016 provides for the guidelines for the Lupong Tagapamayapa Incentives Awards (LTIA);

WHEREAS, under the above mentioned guidelines (DILG MC No. 2016-58), all Lupons nationwide are covered by the annual Awards, and for this year the search will start this I<sup>st</sup> week of October, 2016 for the Municipal Level;

- 3. Select and submit to the Provincial Awards Committee (PAC) the best performing Lupon within the Municipality;
- 4. May secure funding and counterpart prizes from the partner Agencies and the Private sector, and
- 5 May plan and implement appropriate awarding ceremonies.
