SUBJECT : Designation as MENR Officer

You are hereby designated as Municipal Environment and Natural Resources Officer (MENRO) and shall perform the following functions, among others:

1. Formulate measures for the approval of the Sangguniang Bayan and provide technical assistance and support to the Municipal Mayor in carrying out measures to ensure the delivery of basic services and provision of adequate facilities relative to environment and natural resources services as provided for under Sec. 17 of RA 7160.
2. Develop plans and upon approval thereof by the Mayor, implement the same particularly those which have to do with environment and natural resources programs and projects.
3. Be in the frontline of the delivery of services concerning the environment and natural resources particularly in the renewal and rehabilitation of the environment during and in the aftermath of man-made and natural calamities and disasters.
4. Recommend to the Sangguniang Bayan and advise the Mayor on all other matters relative to the protection, conservation, maximum utilization, application of appropriate and other matters related to environment and natural resources.
5. In addition to the foregoing duties and functions, the Municipal Environment and Natural Resources Officer shall:
  - a. Establish, maintain, protect and preserve communal forests, watersheds, tree parks, mangroves, greenbelts and similar projects and commercial forest, like industrial tree farms and agro-forestry projects.
  - b. Provide extension services to beneficiaries of forest development projects and technical financial and infrastructure assistance.
  - c. Provide extension services to beneficiaries of forest development projects and render assistance for natural resources-related conservation and utilization activities consistent with ecological balance.
  - d. Coordinate with government agencies and non-governmental organizations in the implementation of measures to prevent and control land, air and water pollution with the assistance of the DENR.
  - e. Implement the Ecological Solid Waste Management and other environmental ordinances of the municipality
6. Exercise such other powers and perform such other duties and functions as may be prescribed by law or ordinance.

You shall perform this function in addition to your tasks as Administrative Officer V under the Municipal Mayor's Office.
