WHEREAS, the Municipality of La Trinidad, through its Bids and Awards Committee (BAC), advertised the Invitation to Apply for Eligibility and to Bid for the project:

WHEREAS, in response to the said advertisement, only one prospective bidder submitted its bid proposal which passed the preliminary evaluation of bids on December 15, 2015 with the following results:
