BAC Resolution Declaring Single Calculated Responsive Bid & Recommending Approval

WHEREAS, the Municipality of La Trinidad, through its Bids and Awards Committee (BAC), advertised the Invitation to Apply for Eligibility and to Bid for the project:

IMPROVEMENT OF BARANGAY ROAD

WHEREAS, in response to the said advertisement, only one prospective bidder submitted its bid proposal which passed the preliminary evaluation of bids on June 28, 2016 with the following results:

- To recommend for approval by the Municipal Mayor of the Municipal Government of La Trinidad the foregoing findings.
