- To declare **ADL GENERAL CONSTRUCTION** as the bidder with the **Single Calculated and Responsive Bid** for the project "IMPROVEMENT OF BARANGAY ROAD" in the amount of **THREE HUNDRED NINETY NINE THOUSAND FIVE HUNDRED ONE PESOS AND THIRTY ONE CENTAVOS (PHP 399,501.31)**;
