WHEREAS, the Municipality of La Trinidad, through its Bids and Awards Committee (BAC), advertised the Invitation to Apply for Eligibility and to Bid for the project:

REHABILITATION OF CONFERENCE ROOM AND MEZZANINE

in the PhilGEPS and in the conspicuous place at the premises of the Municipality of La Trinidad continuously for seven (7) days;

WHEREAS, in response to the said advertisement, only one prospective bidder submitted its bid proposal which passed the preliminary evaluation of bids on October 17, 2016 with the following results:

- To recommend for approval by the Municipal Mayor of the Municipal Government of La Trinidad the foregoing findings.






