BAC Resolution Declaring Single Calculated Responsive Bid & Recommending Approval

WHEREAS, the Municipality of La Trinidad, through its Bids and Awards Committee (BAC), advertised the Invitation to Apply for Eligibility and to Bid for the project:

CONSTRUCTION OF TALINGUROY E/S COMFORT ROOM

in the PhilGEPS and in the conspicuous place at the premises of the Municipality of La Trinidad continuously for seven (7) days;
