Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
4. Interested Bidders may obtain further information and inspect the Bidding Documents at the address given below from 8:00 A.M. to 5:00 P.M., Mondays to Fridays.

A complete set of Bidding Documents may be acquired by interested Bidders on *May 14-June 2, 2021* at the given address below and upon payment of non-refundable fee for the bidding documents, pursuant to the latest guidelines issued by GPPB in the amount of *FIVE THOUSAND PESOS ONLY (PHP5,000.00)*.

7. Bids must be duly received by the BAC Secretariat at the office address indicated below on or before *June 3, 2021, at 11:30 A.M.* Late bids shall not be accepted.
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.
9. Bid opening shall be on *June 3, 2021*, at 1:30 P.M. at the Mayor's Office Conference Room, 2<sup>nd</sup> Flr. Municipal Hall Building, Km. 5, Pico, La Trinidad, Benguet. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
