ADMINISTRATIVE ORDER
NO. 002 - 2019

AN ORDER DESIGNATING MR. ORLANDO B. PACYA, COOPERATIVE DEVELOPMENT SPECIALIST I, AS THE LOCAL YOUTH DEVELOPMENT OFFICER (LYDO) IN THE LOCAL GOVERNMENT UNIT OF LA TRINIDAD, BENGUET.

WHEREAS, Republic Act No. 10742, otherwise known as the Sangguniang Kabataan (SK) Reform Act of 2015 and its implementing Rules and Regulations, provides for the creation of a Youth Development Office in every province, city and municipality;

WHEREAS, DILG Memorandum Circular No. 2017-36 dated February 24, 2017 mandates all Provincial Governors, City and Municipal Mayors to create their respective Local youth Development Office within their areas of jurisdiction;

WHEREAS, with the limitations on personnel services, a Youth Development Officer shall be designated in order to serve the purpose and shall be under the Office of the Municipal Mayor;


NOW, THEREFORE, I, ROMEO K. SALDA, duly elected Municipal Mayor of La Trinidad, Benguet, by virtue of the power vested in me by law, do hereby designate **MR. ORLANDO B. PACYA, Cooperative Development Specialist I**, as the **LOCAL YOUTH DEVELOPMENT OFFICER (LYDO)** of the Local Government Unit of La Trinidad, Benguet with the following functions;

I. FUNCTIONS

1. Register and verify youth and youth-serving organizations (subject to the revitalized Youth Organizations Registration Program (YORP) guidelines) in accordance with Section 24 (d) of RA 10742;
2. Provide technical assistance to the Local Youth Development Council in the formulation of Local Youth Development Plan;
3. Facilitate the election of LYDC representatives;
4. Serve as Secretariat to LYDC;
5. Conduct mandatory and continuing training of SK officials and LYDC members, in accordance with the programs jointly designed and implemented by the National Youth Commission (NYC) and DILG;
6. Provide technical, logistical and other support in the conduct of mandatory and continuing trainings. Programs and such other programs of NYC and DILG;
7. Coordinated with the Commission, with regard to the youth programs within your jurisdiction; and
8. Perform such other functions as may be prescribed by law, ordinance, or as LCE, the DILG or the NYC may require.

Effectivity. This order shall take effect immediately upon approval thereof and shall remain in full force and effect unless sooner revoked or amended by the Local Chief Executive.
