



ADMINISTRATIVE ORDER
No. 028-2019

REORGANIZING THE TASK FORCE AND INSPECTION TEAM TO IMPLEMENT THE PROVISIONS OF ORDINANCE NO. 06-2013 OF THE MUNICIPALITY OF LA TRINIDAD, PROVINCE OF BENGUET.

WHEREAS, Section 447 of the Local Government Code provides that the Sangguniang Bayan “shall regulate activities relative to the use of land, buildings, and structures within the municipality in order to promote their general welfare and for said purpose shall regulate the sale, giving away or dispensing of any intoxicating malt, vino, mixed or fermented liquors at any retail outlet”;

WHEREAS, Ordinance No. 06-2013 entitled, “*Regulating the Establishment, operation, and Maintenance of Bars, Restaurant, and Other Similar Places of Entertainment Serving Alcoholic Beverages, Providing Penalty For Violation Thereof and For Other Purposes in the Municipality of La Trinidad, Benguet*” was issued on October 2013 and Section 6 of said ordinance mandated the creation of a Task Force to evaluate, inspect, and enforce the provisions of the Ordinance ;

WHEREAS, Administrative Order No. 16, s.2014 was issued on March 25, 2014 creating the Task Force and was subsequently reorganized to replace and add members for the full realization of the objectives of the Task Force;

WHEREAS, due to the election conducted last May 2019, there is a need to reorganize said Task Force to update its membership and replace members who no longer represent their department or agency;

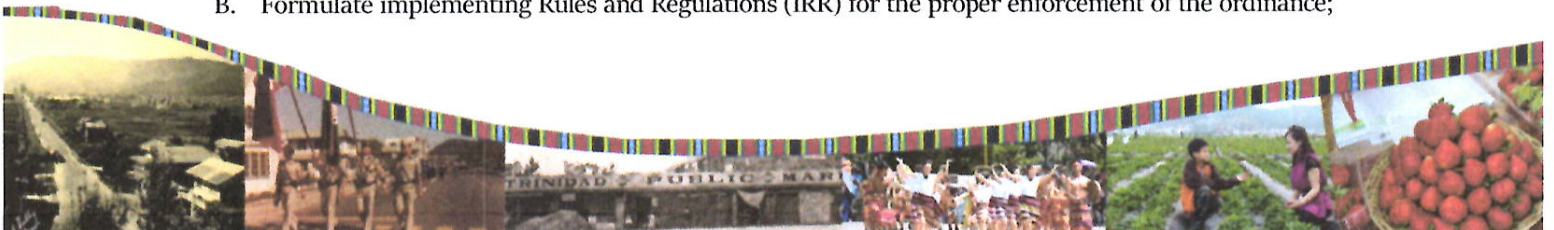
NOW THEREFORE, I, ROMEO K. SALDA, by virtue of the powers vested upon me by law as the duly elected Municipal Mayor of La Trinidad, Benguet, do hereby reorganize the Task Force to evaluate, inspect, and enforce the provisions of Ordinance No. 06-2013 of the Municipality of La Trinidad, Province of Benguet as follows:

SECTION 1. COMPOSITION. The Task Force shall be composed of the following:

SECTION 2. FUNCTIONS. The Task Force shall perform the following functions:

- A. Monitor the actual enforcement of the provisions of the ordinance;
- B. Formulate implementing Rules and Regulations (IRR) for the proper enforcement of the ordinance;

- D. Supervise and monitor the Inspection Team;
- E. File necessary charges in court for violation of this ordinance;

SECTION 4. INSPECTION TEAM. There shall be an Inspection team of the Task Force which shall be composed of the following:



SECTION 5. FUNCTIONS OF THE INSPECTION TEAM. The Inspection Team shall perform the following functions:

- A. Conduct the actual enforcement of the provisions of the ordinance;
- B. Conduct actual inspection and evaluation of bars, restaurants and other similar places of entertainment serving alcoholic beverages;
- C. Implement closure or revocation orders issued by the Office of the Mayor and actual inspection of business establishments;
- D. Coordinate with the concerned Punong Barangay of the intended enforcement of the closure or revocation orders or actual inspection of establishments within their jurisdiction;
- E. Submit a report to the Task Force and other concerned offices every after enforcement of closure or revocation orders or actual inspection of the business establishment;
- F. Perform other related functions as may be assigned by the Municipal Mayor

SECTION 3. EFFECTIVITY. This Administrative Order shall take effect immediately until amended or revoked.
