**ADMINISTRATIVE ORDER**  
**No. 040(A) - 2016**

**AN ADMINISTRATIVE ORDER AMENDING ADMINISTRATIVE ORDER NO. 040-2016 ENTITLED "CREATING THE SCREENING COMMITTEE ON ELECTRICAL CONNECTION PURSUANT TO ORDINANCE NO. 11, s. 2016 OF THE MUNICIPALITY OF LA TRINIDAD, PROVINCE OF BENGUET."**

**WHEREAS**, Sangguniang Bayan issued Ordinance No. 11-2016 entitled, *"Prescribing Guidelines in the Issuance of Certificate of Final Electrical Inspection (CFEI) for Certain Building Structures in the Municipality of La Trinidad, Benguet and for Other Purposes;*

**WHEREAS**, in the said ordinance, it required the creation of a Screening Committee to evaluate applications for electrical connection;

**WHEREAS**, on August 28, 2016, the Institute Of Integrated Electrical Engineers of the Philippines, Inc. – Baguio-Benguet Chapter President Engr. Ariel S. Cabutotan, designated, Engr. Joey Jovencio L. Marrero, a member of the association, as the representative of the association in the said committee;

**NOW THEREFORE, I, ROMEO K. SALDA**, duly elected Municipal Mayor of the Municipality of La Trinidad, Benguet, and by the powers vested in by law, do hereby amend the Screening Committee on Electrical Connection pursuant to Ordinance No. 11, s.2016 as follows:

**Section 1. Composition.** The Screening Committee shall be composed of the following:

<b>Chairman</b>	:	HON. ROMEO K. SALDA, Municipal Mayor
<b>Co-Chairman</b>	:	HON. ARTHUR M. SHONTOGAN, SB Chairperson, Com. On Public Utilities
<b>Members</b>	:	HON. TEDDY M. QUINTOS, ABC President ENGR. JOEY JOVENCIO L. MARRERO, Member, IIEE of the Philippines, Baguio-Benguet Chapter MR. FRANCIS A. LEE, Executive Assistant II
<b>Secretariat</b>	:	Mr. Joel M. Cervantes Ms. Sicily T. Serrano Mr. Jonjon L. Abando

**Section 2. Functions.** The Committee shall perform the following functions:

1. Oversee/screen applicants for electric connection to certain structures constructed within the municipality of La Trinidad, Benguet without the necessary building permit;
2. Refer approved applications to the Municipal Engineering Office for further inspection, verification, and testing of electrical wirings and compliance to the provisions of the Philippine Electrical Code;
3. Formulate and adopt guidelines and procedures that may facilitate the process of approval of applications not contrary to PD 1096(Building Code of the Philippines) and RA 7279 (Urban Development and Housing Act of 1992)
4. Recommends to the offices of the Sangguniang Bayan and the Municipal Mayor other guidelines and policies on the issuance of Certificate of Final Electrical Inspection by the Municipality of La Trinidad, Benguet for local legislation and or implementation;



**Section 3. Functions of the Secretariat.** The Secretariat shall perform the following functions:

1. Shall receive and initially evaluate all applications for electric connection as to compliance with the requirements set forth in Section 3 & 4 of Ordinance No. 11-2016;
2. Prepares communications, recommendations, resolutions and endorsements of the committee to the appropriate/concerned departments/agencies;
3. Document proceedings of the committee;
4. Keep the records of the committee;
5. Does other functions as may be required by the committee;

**Section 4. Effectivity.** This Administrative Order shall take effect immediately and shall be valid until amended and/or revoked.
