



EXECUTIVE ORDER

No. 01-2022

AN ORDER AMENDING EXECUTIVE ORDER NO. 130-2021 AND IMPLEMENTING THE BUSINESS ONE STOP SHOP FOR BUSINESS REGISTRATION AND PERMIT RENEWAL FOR THE YEAR 2022 IN THE MUNICIPALITY OF LATRINIDAD, PROVINCE OF BENGUET, AND PROVIDING GUIDELINES THEREFOR

WHEREAS, per its Resolution No. 226-2021, the Sangguniang Bayan approved the conduct of the Business One Stop Shop (BOSS) for the first two (2) months of the first quarter of each year for business registration and renewal;

WHEREAS, to facilitate the application and processing of new and renewal of business permits for the year 2022, there is a need to implement a two-month period to accommodate and assist the applications for said business permits;

WHEREAS, in view of the promulgation of the Market Ordinance which include a provision for a three-month transition period, it is deemed proper that business entities within the 1993 and 2002 La Trinidad Public Markets be scheduled separate from the timetable falling within the first two months of the first quarter of the year 2022;

WHEREAS, in order to further facilitate the processing of new and renewal of business permits for the year 2022, it is likewise deemed appropriate that the business entities within the La Trinidad Vegetable Trading Post and those falling within the La Trinidad municipal lots be given a schedule similar to those under the 1993 and 2002 La Trinidad Public Markets;

NOW THEREFORE, I, ROMEO K. SALDA, by virtue of the powers vested in me by law as the duly elected Municipal Mayor of La Trinidad, Benguet, Philippines, do hereby order the following:

SECTION 1. BUSINESS ONE STOP SHOP (BOSS) SCHEDULE. The schedule for business registrants shall be as follows:

- a. **For the month of January 2022** – Those whose surnames (for single proprietorship) and/or corporate names (for corporations, partnerships, cooperatives and similar entities) starting with letters **A – J**. (This shall include all entities whose corporate names start with numbers or numerical value);
- b. **For the month of February 2022** – Those whose surnames (for single proprietorship) and/or corporate names (for corporations, partnerships, cooperatives and similar entities) starting with letters **K – Z**; and

SECTION 2. EXCLUSION. The schedule provided under Section 1 hereof does not apply to those entities falling under the 1993 and 2002 La Trinidad Public Markets, the La Trinidad Vegetable Trading Post, and those falling within the La Trinidad municipal lots. Said entities are excluded from the coverage of Section 1 hereof. Their schedule for the BOSS will instead be in March 2022.

SECTION 3. VENUE. The venue for the Business One Stop Shop will include the municipal gymnasium and the municipal park/ground.

SECTION 5. MINIMUM HEALTH STANDARDS. The minimum public health standards shall be strictly complied with during the BOSS activity.

SECTION 6. SEPARABILITY CLAUSE. In case any provision in this Executive Order is declared invalid, illegal or unenforceable, the validity, legality and enforceability of the remaining provisions shall not in any way be affected.

SECTION 7. EFFECTIVITY. This Order shall take effect immediately until sooner revoked or amended.
