**EXECUTIVE ORDER**  
**No. 07-2022**

**AN ORDER IMPLEMENTING A TEMPORARY TRAFFIC SCHEME FOR TAXIS PLYING THE MUNICIPALITY OF LA TRINIDAD, PROVINCE OF BENGUET TO SYNCHRONIZE WITH THE TRAFFIC SCHEME IN THE CITY OF BAGUIO FROM FEBRUARY 1-28, 2022**

**WHEREAS**, effective February 1 to 28, 2022, the City of Baguio will be implementing a temporary traffic scheme for taxis which is in conflict with the number coding scheme being implemented in the municipality of La Trinidad;

**WHEREAS**, on 20 January 2022, the Municipal Inter-Agency Task Force (MIATF) convened and it was recommended during said MIATF meeting that the temporary taxi coding be adopted by the Municipality;

**WHEREAS**, in due consideration of the foregoing and so as not to cause confusion and difficulty to both the commuting public and taxi drivers/operators entering La Trinidad, the Municipality hereby resolved to adopt the temporary traffic scheme for taxis for the period February 1-28, 2022;

**NOW THEREFORE**, I, **ROMEO K. SALDA**, by virtue of the powers vested in me by law as the duly elected Municipal Mayor of La Trinidad, Benguet, Philippines, do hereby order the following:

**SECTION 1. TEMPORARY TRAFFIC SCHEME SCHEDULE.** The following traffic scheme shall be followed for the period **FEBRUARY 1 TO 28, 2022** for taxis plying the municipality of La Trinidad and shall be allowed to ply from **6:00 AM to 6:00 AM** the following day:



**SECTION 2. MINIMUM HEALTH STANDARDS.** Taxis should strictly implement minimum health standards and the “NO Face Mask and Face Shield, NO RIDE” policy. This shall be in addition to the provisions and health and safety protocols stipulated in LTFRB Memorandum Circular No. 2020-018.

**SECTION 3. SEPARABILITY CLAUSE.** In case any provision in this Executive Order is declared invalid, illegal or unenforceable, the validity, legality and enforceability of the remaining provisions shall not in any way be affected.

**SECTION 4. EFFECTIVITY.** This Order shall take effect immediately until sooner revoked or amended.
